Thank you for your letter of June 24, 2007.

Seaman Second Class Baldwin is interred in the Manila American Cemetery as indicated in the above caption. Information concerning the cemetery may be found on the tabbed pages of the enclosed pamphlet. At the time of his death, November 1, 1944, S2C Baldwin was serving with the US Naval Reserve.

In approximately six to eight weeks we will mail you a black and white photograph of S2C Baldwin's grave site. The photograph will be mounted on a color lithograph of the cemetery. Along with the photo and lithograph, we will also enclose a booklet describing the cemetery in detail.

Arrangements for placement of floral decorations at the grave site can be made through this Commission using the enclosed forms. Checks or money orders for floral decorations should be made payable to the ABMC Flower Fund. As a guide, the cost of a suitable bouquet or spray in that area ranges from \$10.00 to \$29.00. Weather permitting, a color digital photograph of the decoration in place will be taken and forwarded to you.
